

VISIONARIA FOR SCHOOLS IS A TEACHER TRAINING AND SUPPORT PROGRAM FOR SECONDARY SCHOOLS. THE GOAL OF THIS PROGRAM IS TO ENABLE ALL STUDENTS IN PARTICIPATING SECONDARY SCHOOLS TO CONTRIBUTE TO SUSTAINABLE DEVELOPMENT PROJECTS IN THEIR COMMUNITIES. THE PROGRAM INCLUDES TEACHING STRATEGIES, COACHING SUPPORT, AND TEAM-BASED PROJECT ACTIVITIES FOR USE IN THE CLASSROOM THAT BUILD STUDENTS' SOCIO-EMOTIONAL SKILLS AND COLLABORATE WITH OTHER COMMUNITY LEADERS.

IN 2018 THE PROGRAM GREW THROUGH A PARTNERSHIP WITH A PROVINCIAL MINISTRY OF EDUCATION IN ANTA, CUSCO, PERU AND REACHED OVER 1,100 STUDENTS IN 12 DIFFERENT SCHOOLS. ADDITIONAL RESEARCH WAS ALSO CONDUCTED ON THE PROGRAM IN 2018 TO EXPLORE THE EFFECTIVENESS AND IMPACT OF THE PROGRAM ON TEACHERS.
