THE VISIONARIA FOR SCHOOLS PROGRAM IS TO ENABLE ALL STUDENTS IN PARTICIPATING SECONDARY SCHOOLS TO CONTRIBUTE TO SUSTAINABLE DEVELOPMENT PROJECTS IN THEIR COMMUNITIES. THE PROGRAM INCLUDES TEACHING STRATEGIES, COACHING SUPPORT, AND TEAM-BASED PROJECT ACTIVITIES FOR USE IN THE CLASSROOM THAT BUILD STUDENTS' SOCIO-EMOTIONAL SKILLS AND COLLABORATE WITH OTHER COMMUNITY LEADERS. IN 2020 THE PROGRAM SHIFTED TO AN ONLINE FORMAT IN RESPONSE TO THE PANDEMIC, BUT ALSO ESTABLISHED PARTNERSHIPS WITH THE STATE MINISTRY OF EDUCATION IN CUSTO TO OFFER THE VISIONARIA CURRICULUM MORE BROADLY. THE PROGRAM ALSO CONTINUED OFFERING THE "LEADER WITH A VISION PRIZE" TO ELIGIBLE STUDENT TEAMS, AND INCORPORATED A NEW "WALK THE TALK" TEACHER TRAINING ADDITION TO PROMOTE GENDER EQUALITY AND EQUAL PARTICIPATION IN THEIR CLASSROOMS.
